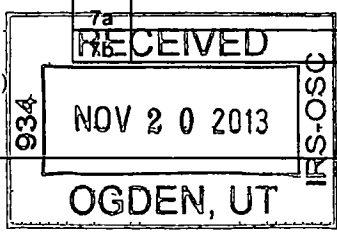





The Institute helped develop literature on marriage as an institution as it relates to Catholic, Christian, Jewish, and secular perspective. The Institute provided input, to include testimony to courts, commissions, and educational institutions, on the religious, societal, and cultural history of marriage. The Institute published "iMAPP Marriage News", a weekly compendium of the five most interesting or relevant marriage stories. It went to over 4,000 free subscribers.
