The most significant efforts in 2012 included the filing of three US Supreme Court amicus briefs in NFIB v. Sebelius (Obamacare SCOTUS litigation): two on the merits for Speaker Boehner and a group of 44 Republican Senators, one on severability for a group of 36 Republican Senators. This included extensive print, TV, and radio media, including as a guest on NPR, MSNBC, Diane Rehm, FOX, CNN, and CNBC. Additionally, testified before Health Subcommittee of House Ways and Means Committee regarding judicial nomination of Andrew Herwitz and criticized the American Bar Association's involvement in judicial ratings. The Organization also was active regarding the Dodd-Frank bill, with print and radio media surrounding the filing of a lawsuit. The Organization continued progress of FOIA lawsuit initiated in March 2011, coordinating with Chairman Smith of the House Judiciary Committee in order to encourage their investigation of incomplete FOIA disclosures by the US Department of Justice, radio, and print media.
