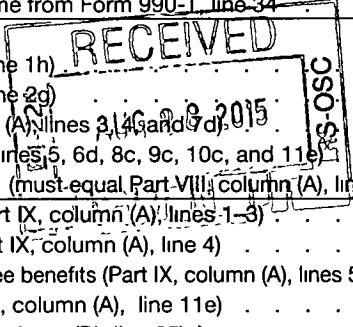

- 1 Briefly describe the organization's mission: The Center is a public policy "think tank" designed to identify and provide the research and analysis needed to address the most critical public policy, economic, educational and governance issues affecting the citizens of Rhode Island.

Research & Studies - School Choice - the Center continued its school choice scholarship initiative by contracting for 3rd party research, contracting to construct a dedicated website, and preparing other marketing and outreach programs for 2015.
Health Care - with regard to healthcare the Center contracted for 3rd party research and became involved with the debate as to whether or not the state should continue to fund its ACA health insurance exchange.
Con-Con - The Center published research and its perspectives, co-partnered in commissioning a public survey, and took a public education leadership role on a public referendum ballot initiative on voter approval of a statewide constitutional convention.
The Center also completed work on its multi-year mens rea (or criminal intent) project by hiring a 3rd party legal entity for consulting services and to conduct limited lobbying on behalf of a bill that would require a conscious criminal intent before prosecutions could occur on a variety of obscure statutes in the state's criminal code.

Transparency - In this reporting period the Center continued to publish the Ocean State Current-Anchor - a daily online blog/newsletter discussion of topical and pressing public policy issues. This effort continued to grow in scope and included a series of appearances on local media (television) public events shows. The Current-Anchor published hundreds of posts over the course of the year on a wide variety of topics, with the editor appearing on a Sunday local NBC TV station political roundtable two to three dozen times, as well as an additional handful of times about other state and local transparency products produced by the Center.
The Center continued its existing initiative to make public payments and votes by individual legislators readily available online for citizen review. The Center continued to operate two websites - RIOpenGov.com and RIVotes.com, which provided the public with analysis of pending legislation and how individual votes were cast. The Center also continued to publish a "report card" of state government effectiveness over a range of measurement areas.

Advocacy & Outreach - In furtherance of its coalition building and grass roots organizing initiatives, the Center continued hosting regular meetings attended by reform and taxpayer advocacy groups in the state. These meetings provided an important forum where information was shared and where concepts for cooperative outreach and grass roots advocacy and coalition building activities were planned and nurtured.
